The Bidder further declares that he/she has examined the site of the work and has become thoroughly familiar with all conditions pertaining to the places where the work is to be done; that he/she has examined the plans and specifications

for the work and contractual documents relative thereto, and has read all special provisions furnished prior to the opening of bids; that he/she has been satisfied relative to the work to be performed.

The Bidder further proposes and agrees to complete all work within _____ calendar days after award of the contract by the Board. The contract period includes twenty days time to the contractor to furnish acceptable surety bond and insurance forms, at which time a **Notice of Commencement** will be issued by the Owner.

The Bidder further proposes and agrees that, in case of failure on the Bidder's part to furnish acceptable surety bond (only if bid exceeds \$200,000) and insurance within twenty (20) consecutive calendar days or to execute the contract within forty-five (45) consecutive calendar days after award of the contract, the check or bid bond accompanying this bid, and the monies payable thereon, shall be paid into the funds of the School Board of Miami-Dade County, Florida, as liquidated damages for such failure; otherwise the check or bid bond accompanying this proposal will be returned to the undersigned.
