  - (c) Partners Signed by one Partner, 2 Witnesses and notarized.
- 2. Five originals of this Requisition and Release must be submitted to the School Board of Miami-Dade County, Florida.
- 3. This Requisition and Release must be executed in addition to any other method and/or evidence that may be required of the Design Builder to substantiate payment of bills.
- 4. In the event this Requisition constitutes request for Final Payment, check appropriate square.
- 5. Any necessary changes made by the Design Criteria Professional which correct the sums requested by this Requisition shall contain the initials of the person authorizing the change beside each such change.
- 6. This Requisition will not be honored unless the blank space in the Oath of the Design Builder is filled with the appropriate amount of the preceding Requisition.
- 7. Each person signing the Design Builder's Oath in this Requisition assumes individual responsibility for the truth of the statements in the Design Builder's Oath in addition to binding the firm he or she represents.
